## **MAY DRUG ARRESTS**

\*\*All individuals are presumed innocent until found guilty in a court of law\*\*

A month-long investigation by drug investigators and uniform patrol led to a traffic stop on Highway 66 over the weekend.

A suspected drug dealer, Timothy Gavin, was a passenger in a car that was stopped by Uniform Patrol Sgt. Justin Osborn Sunday morning May 5th.

Probable cause was established, and a search of the vehicle was conducted with an amount of a controlled substance being located.

Timothy John Gavin, age 26, Blairsville, was arrested and charged with:

Felony Distribution of a Controlled Substance

Felony Possession of a Controlled Substance

Failure to Wear Seatbelt

Towns County drug investigators contacted Union County Sheriff's Office Major Shawn Dyer Sunday afternoon. A search warrant was obtained by Union County Sheriff's Office Drug Unit and was executed along with Towns County Sheriff's Office at Gavin's residence in Union County.

An amount of Methamphetamine, guns, and cash were recovered.

Charges are forthcoming by Union County Sheriff's Office.





On Saturday, May 11th, Towns County Sheriff's Office deputies assisted the Georgia Highway Patrol on a traffic stop on Highway 66.

Probable cause was established, and a search of the vehicle resulted in the confiscation of Methamphetamine, which field-tested positive, and drug related objects.

Anthony Howard Holcombe, age 54, Homeless was arrested and charged with:


- Felony Possession of Methamphetamine

# ILLEGAL IMMIGRANT DETAINED - WANTED BY I.C.E.

Sunday, May 5th, Alfonso Esteban Botista was booked into the Towns County Detention Center, having been charged with Driving Under the Influence, Driving without a Valid License, and brake light/turn signal violations. Sheriff Ken Henderson notified detention officers to contact immigration officials (ICE) to verify Botista's immigration status. It was discovered Botista is an undocumented immigrant.

Botista also has warrants out of Florida for Failure to Appear.

I.C.E. placed an immigration hold on Botista and will be picking him up.

# **BURGLARY SUSPECT APPREHENDED**

On May 25th at 6:00 AM The Oaks Restaurant reported a burglary. The manager stated that someone had entered the restaurant during the night and forced open the safe and stole an undisclosed amount of cash. During the investigation, it was discovered that Deputy Vonya Baldwin had been patrolling the area at 3:00 AM and noticed an unattended motorcycle parked on Lakeview Drive near The Ridges complex which was registered to an

Further investigation and canvass of the area revealed the employee and motorcycle were on video from an area surveillance camera.

The employee, identified as Richard Lee Hall, age 38, Young Harris, was arrested and charged with Felony Burglary in the Second Degree, and is being held without bond. The money was recovered and returned to the owner. Sheriff Ken Henderson commends Deputy Baldwin for his dedication and commitment to his patrol duties. His observation and detail to his duty, by running the tag on an unattended motorcycle which quickly identified the suspect enabling a swift arrest.



#### ARRESTS DURING JOINT OPERATION WITH CLAY COUNTY SHERIFF'S OFFICE

towns County Sheriff's Office Drug Investigator received multiple complaints regarding drug activity at Windy Hill gas station on Hwy 66, near the NC/GA state line.

During the investigation, store videos revealed a drug transaction between the store clerk and another individual. The clerk, identified as Rodney Alan Powell, age 46, Marble NC was arrested, and a search of the individual resulted in Methamphetamine on his person. He is charged with:

- Felony Possession of Methamphetamine
- Possession of Drug Related Objects

The other individual was identified as Gary Lee Hamrick, age 52, Warne, NC.

Clay County Sheriff's Office was contacted, and a search warrant was issued and served at 983 Ford Road, Warne, NC by Clay County Sheriff's Office and Towns County Sheriff's Office.

During the search, Methamphetamine, which field-tested positive, was confiscated from another occupant at the residence identified as Charlene Whisenant, age 71, Warne NC. Whisenant was arrested by Clay County Sheriff's Office and charged with Possession of Methamphetamine. She received a \$10,000 secure bond for Possession of Methamphetamine and Maintaining a Dwelling for the Keeping of Controlled Substance.

Gary Lee Hamrick, age 42, Warne NC was arrested by Clay County Sheriff's Office for Felony Probation Violation and is being held without bond.

Towns County Sheriff's Office has pending narcotics charges for Gary Lee Hamrick.

Towns County Sheriff Ken Henderson and Clay County Sheriff Mark Buchanan are pleased with the joint effort and coordination by both offices' investigators and deputies. The working relationship between both agencies on closely related criminal activity will enhance the safety of our communities.
